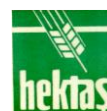

Skin contact

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison Control center or doctor for treatment advice if effects persist.

Eye contact

Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, and then continue rinsing eyes. Call a poison control center or doctor for treatment advice if effects persist.

Ingestion

Swallowing: If the patient is conscious, induce vomiting. Do not give anything by mouth when he is conscious. Call a doctor and take the medicine label and packaging together.

SYMPTOMS OF POISONING: A metallic flavor in the mouth, bloody diarrhea, green-blue vomiting, rapid breathing, excitement, dizziness, headache, weakness, nausea, blurred vision, heavy metal in the stomach and intestines (5--8 g) poisoning, loss of water and electrolytes

NOTE: There is no special antidote. Treatment is applied according to the symptoms.
