## 4. FIRST AID MEASURES

### 4.1 Description of first aid measures

#### General advice

Move out of dangerous area. Place and transport victim in stable position (lying sideways). Remove contaminated clothing immediately and dispose of safely.

#### Inhalation

Move to fresh air. Keep patient warm and at rest. If effects occur, consult a physician.

#### Skin contact

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison Control center or doctor for treatment advice if effects persist.

#### Eye contact

Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, and then continue rinsing eyes. Call a poison control center or doctor for treatment advice if effects persist.

#### Ingestion

Do not induce vomiting unless told to do so by the poison control center or doctor. Never give anything by mouth to an unconscious person. Get medical attention immediately.

**Symptoms of poisoning:** If the drug is swallowed, there may be imbalance in the movements and neural symptoms such as need. If the drug is too high for the skin, there may be signs of temporary skin sensitivity such as numbness, burning and numbness on the skin, especially the face.

**NOTE:** If swallowed, the stomach should be washed with care to avoid drowning of the patient, followed by PHENOBARBITAL or DIPHENYL HYDANTOIN or a mixture thereof
