In the Facility, in addition to the planting and sowing areas where hundreds of varieties are located, IoT Artificial Intelligence Laboratories, High-Tech Biopesticide Production Center, Technological and Sustainable Agricultural Production Complex, IoT-based infrastructures of the Traceable Safe Food Platform, Producer Information Center, Agriculture Museum, as well as an Accommodation Facility, Conference Hall and Exhibition Hall will also operate in the the Smart Agricultural Technologies and R&D Innovation Center.

As of 2022 First Quarter

The works carried out within the framework of Hektaş's vision and mission have been presented with practical examples to the stakeholders hosted at the facility, and mutual information was exchanged. Manufacturer expectations and feedback are taken into account as a source for R&D studies.

1,233 producers/stakeholders operating on a total of 599,040 decares of agricultural land have been hosted.

### ARMA



- Arma İlaç which was % 100 purchased in 2021 third quarter, is continuing activities veterinary medicine production area with export high potential productions and has the motto of "One Health, One Arma", with its facility holding the "GMP Production Certificate" that is known "good manufacturing practices".
- It is one of 30 GMP certificate facilities that received from Turkey's Ministry Of Agriculture And Forestry
- Innovative products which are increased export potential and improve production portfolio, is produced.









### AGRIVENTIS

- 51% share of the Australian origin company which grows multi-purpose and drought-tolerant seeds, was purchased in 2022 first quarter.
- Our subsidiary is continuing activities in the field of "seed-growing and seed improvement".
- R&D studies, which are not very common in Turkey, will be started, such as strengthening foreign R&D cooperations in the field of seeds and developing productive and very diverse seeds that can be grown in arid and semi-arid areas.
- There are 263 seed lines in the facility.
- IP process of 13 seeds continues.
- Hektaş's long term aim; to be a global player in seed sector with seeds developed through direction R&D studies to sector for combating climate change.









## **RESEARCH AND DEVELOPMENT ACTIVITIES**



In the First Quarter of 2022

#### At The R&D Center

#### At Areo Tohum Technologies Center;

Elite seed production of two einkorn varieties (Atasiyez and Mergüze), whose sales rights belong to Hektaş, started. Anadolu is its gene source and It is very special wheat which has protected original structure for more than ten thousand years with 14 chromosome.

Production and sales rights of 2 cotton varieties obtained from the project carried out jointly with Nazilli CottonResearch Institute have been received. Production plans for 2022 have been prepared.

A large number of plants set out to be registered at various levels in the Vegetable Breeding Program studying with seeds.

Two techniques have been developed to shorten the long-drawn out seed breeding processes. These techniques are;

1. The Speed Breeding system was established. By eliminating materials that will not serve the purpose, time, energy and cost advantages are provided.

2. Preliminary studies have been started for the optimization of the double haploid method in some selected species.


- With the addition of 8 new projects, a total of 24 projects are still in progress.
- 13 new products that were licensed and offered for sale as outputs of R&D projects in the field of plant protection were commercialized.
- It continued to create fast and effective solutions with its staff of more than 30 competent researchers.





## **2022 FIRST QUARTER ACTIVITIES**

- It purchised 51% of Agriventis Technologies which is improve drought-tolerant seed.
- It started to place in BIST 30 index.
- It was applied to CMB to increase of the authorized capital cap from 1 billion TL to 3 billion TL and it was gotten approval.
- Right Issue and Bonus Issue decision was taken.
- Revenue 147% icreased according to first quarter of the same year.
- Profit 191% icreased according to first quarter of the same year.
- EBITDA (Profit from operating activities + Amortization) 256% icreased according to first quarter of the same year.
- Hektaş Equity has been earned 109% for its investors according to first of the same year.
- HEKTAŞ Equity has been earned his investor 19% annual basis.
- It has been deemed worthy for the fourth time in a row at the 2021 İKMİB Stars of Exportation Awards, organized by the Istanbul Chemicals and Chemical Products Exporters' Association (IKMIB).










### HEKTAŞ IN FIGURES (REVENUE – NET PROFIT)
