



GEBZE PRODUCTION FACILITY

Plant protection, plant nutrition products are produced

It is the first facility in its field to produce in accordance with Industry 4.0 standards

Final investments are anticipated to increase capacity by 116% in 2023 compared to 2020

It accounts for approximately 44% of the plant protection products

Approximately 7% of the products produced at the facility are exported

Plant protection products are produced

The production capacity, which was 8,639 tons/year over 24 hours/day at time of its acquisition, has been increased to 18,500 tons/year over 24 hours/day as of the end of 2022

Its production capacity increased by approximately 114% since its acquisition



HEKTAŞ did the honours II. International Molecular Plant Protection Congress in Bursa Orhangazi F.A.R.M R&D center on the date of 15-18 May 2023

81 foreign scientists participated as speechmakers to congress which was cooperated with the Ministry of Agriculture and Forestry & Ankara University & HEKTAŞ Biology Professor Craig MELLO who has Nobel Reward, made opening speech

There were 40 domestic and foreign shareholders exhibition space.

There were lots of innovations which were include from new generation pesticides to new developed insecticides produced in the congress which was followed over 1000 participant

HEKTAŞ, PROGRESS TOWARDS BEING A GLOBAL TURKISH BRAND



The company made a strategic move, acquiring 51% of Australian-based Agriventis Technologies in 2021, and positioned itself on a global scale as well.

The acquisition was made to reinforce international R&D collaborations in the field of seeds, as well as to carry out R&D works not very common in Turkey, such as developing productive and diverse seeds that can be grown in arid and semi-arid areas.

The company was established in 2022 in Tashkent to operate in the fields of plant protection and plant nutrition in support of export-oriented growth thanks to its proximity to not only the Uzbekistan market, but also other Turkic Republics of the region.

A plant protection production facility with an annual capacity of approximately 30,000 tons and an organomineral fertilizer production facility with a production capacity of 150,000 tons will be established.

The company will be close to the Uzbekistan market as well as other Turkic Republics of the region. A memorandum of understanding was signed in 2022 on cooperation in the field of commodity trade, especially food safety.

Boustead Holdings Berhad

Founded in the early 19th century under the Malaysian army, it is one of the oldest holdings in the country.

It has been traded on the Malaysian Stock Exchange since 1961.

As of the end of 2021, its market value is RM 1.1 Billion, i.e. \$271 million. Its asset size is RM 16.4 billion, i.e. \$404 million, and its total equity is RM 5.5, i.e. \$1,355 million.



The memorandum of understanding for cooperation in the fields of food safety, institutional breeding, agricultural technologies, plant protection, plant nutrition, seed production and import and marketing of pesticides, was signed in 2022.

It is a foundation established in Pakistan. It has 27,000 employees.

It is the group company with the highest revenue and profitability in Pakistan.




